All the data given in the document called „prebooking“ are protected by the Data Protection Act. The collection of personal data including the data processing and data using is only for the task fulfillment. In order to decide on the admittance as well as the procedure of an admittance of children of HMGU employees the leadership of the AWO Kinderhaus „ganz schön frech“ is entitled to transfer the received information to the Human Resources Department of HMGU. In case of a planned admittance of external children to the AWO Kinderhaus „ganz schön frech“ according to §64 Abs. 1 SGB VIII the leadership of the AWO Kinderhaus „ganz schön frech“ is entitled to make a data verification with the community of Oberschleißheim and/or with other day-care centers within this community if it is necessary for the decision relating to the admittance.
