§ 1

Purpose, Opening time

For the attendance at the named Kinderkrippe during the hours

Monday to Thursday from 7:00 am to 5:00 pm
Friday from 7:00 am to 4:00 pm

monthly visit fees, meal fees and other fees are charged according to this fee statute.

§ 2

Persons who owe fees and charges

The fees and charges are owed by the persons entitled to custody. This also applies if other authorised representatives who have provided the required proof of admission have registered the child.

§ 3

Origin and due date of the attendance fees

1. The obligation to pay the attendance fees and other charges arises with the enrolment of the child in the Kinderkrippe. The obligation to pay also exists in case of illness of the child or temporary closure of the facility, as well as during the holiday season.
The fee and other charges are valid until the end of the Kinderkrippe year or until the child enters primary school and, if applicable, beyond that, if the enrolment has not been previously terminated on time and on schedule.
2. The attendance fee is payable in advance by the first of each month.
3. The fee applies regardless of closing times for the entire Kinderkrippe year, which means 12 months a year.
4. Payment is made by direct debit authorisation in the debiting procedure. The account of persons entitled to custody must be covered; any bank charges incurred in the event of a shortage of funds shall be borne by the persons entitled to custody (return debits). Additionally, from the second reminder onwards, a late fee of €10 will be charged, and for the third reminder, a late fee of €20 will be applied, both of which are to be paid by the debtor.
5. If the debtors of the visitation and other fees are in arrears for more than two monthly payments, the care contract will be terminated without notice.

§ 4

Attendance fees / charges

1. Attendance fees are payable as a contribution to the operating costs of the crèche in the following amount:

2. The regulations for the Bavarian parental contribution subsidy in the amount of € 100 stipulate a cut-off date. It is valid from September 1st of the calendar year in which the child turns three and is paid until school starts. This also applies to children in the Kinderkrippe.
3. The core hours depend on the type of facility. The minimum booking time must be observed. We reserve the right to adjust the core booking time for pedagogical and organizational reasons.
4. A minimum attendance of 4 days and 20 hours per week is required. We recommend attendance of the Kinderkrippe on 5 days a week.
5. The booking times are basically for the entire Kinderkrippe year. Transfer is therefore possible only once per Kinderkrippe year and must be announced in writing four weeks in advance. Further changes to the booked care times are only possible in hardship cases on request. This request should be addressed to the facility which decides on the need for a change. During the last 3 months of the Kinderkrippe year, a reduction of booking times not possible. Increasing the booking times is only possible if sufficient staff hours are available.
6. The temporary absence of a child from the Kinderkrippe leaves the fees unaffected. The fee is payable in full even if the child is absent due to illness or personal reasons and the place in the Kinderkrippe is to be kept open for the child.

§ 5

Additional costs

1. The fee for the monthly catering allowance is 140,00€ per month. If the fee changes, it will be adjusted.
2. The closing days of the facility are already included in the meal allowance. There is no refund if the child is ill or absent.
3. The monthly cost for materials is 9,00€.
4. The monthly beverage fee is 2.50€.

5. The catering flat fee and other fees are charged monthly in advance, together with the attendance fees.

§ 6

Attendance fee reduction

1. A reduction or partial assumption of the attendance fee can be applied for in special social and financial-hardship cases at the responsible youth welfare office based on § 90 along with §§ 22 and 24 SGB VIII (Child and Youth Assistance Act).
2. Children of a family from Oberschleißheim, including step-siblings, half-siblings and foster children, receive a discount when attending the aforementioned crèche. The prerequisite for this is that the children live in the same household in the municipality of Oberschleißheim. The existence of the entitlement to a reduction must be proven to the provider.

3. The other fees are not subject to any reduction.

§ 7

Deferral of payment

The attendance fee can be deferred in a revocable way in justified cases at the request of the person entitled to custody.

§ 8

Determination of the attendance fees / charges

1. In agreement with the municipality of Oberschleißheim, a change to the attendance fees can be made by the provider with a notice period of four weeks after written advance notice or posting in the crèche.
2. A change may be made in line with the increase in operating costs (material and personnel costs) and/or the restriction/increase in public subsidies.

§ 9

Scope / entry into force

The fee Statute applies to the named facility and enters into force on 1. September 2026.
